- Infinity serenity pool overlooking the Atlantic.



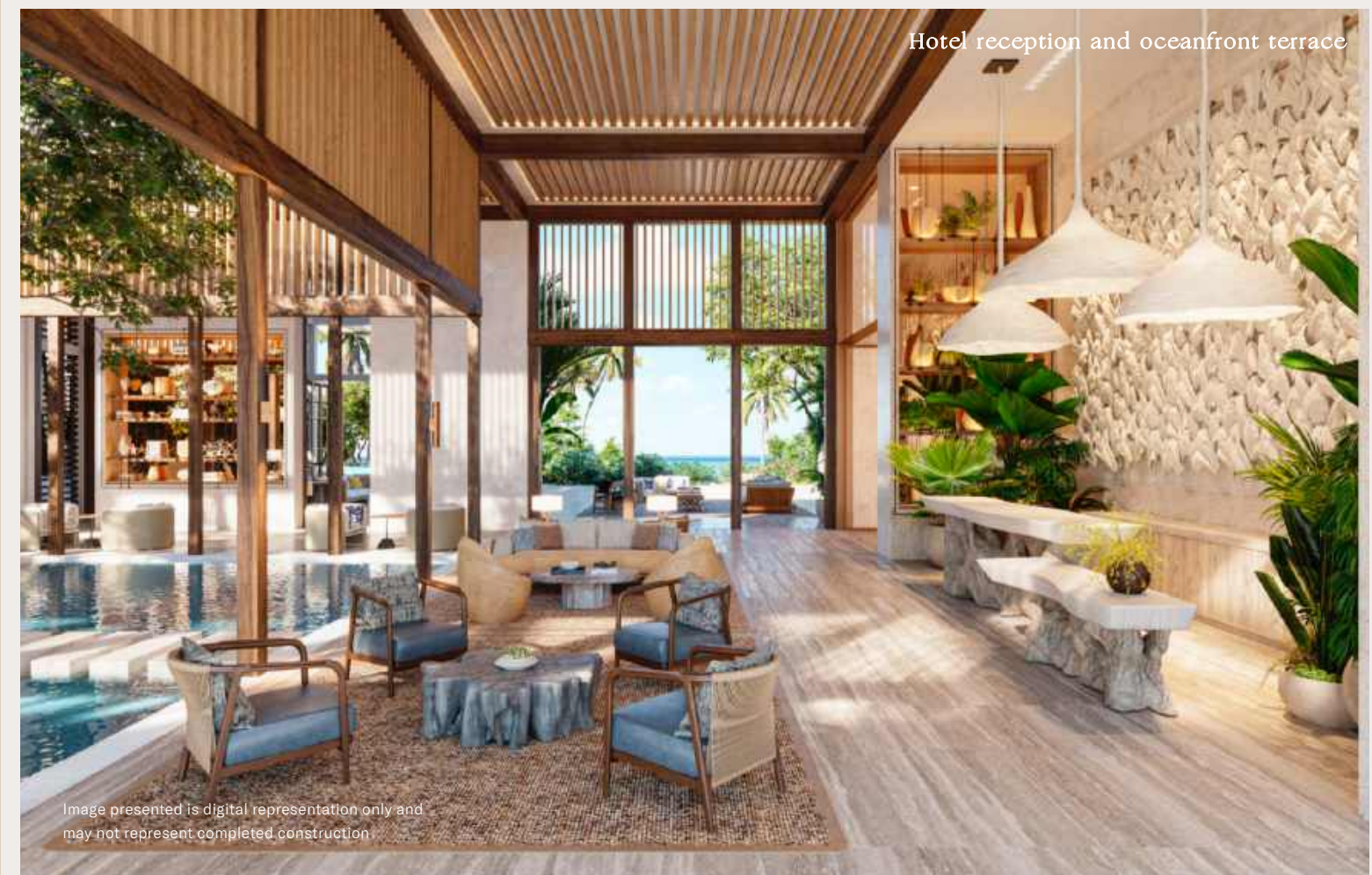
The oceanfront Spa at Mandarin Oriental floats above the Atlantic.

 - Racquet and padel courts, nestled in a garden setting.

Private Residences Beach House

A synthesis of indoors and outdoors, the Beach House residences crown the top five levels of the hotel offering owners immediate access to Mandarin Oriental's amenities, resort pools, and crescent beach. The open, contemporary layouts are designed to erase the boundaries between the indoors and outdoors with all principal rooms showcasing direct views of the beach and ocean.

- An exclusive offering of 20 two, three- and four-bedroom residences with expansive private outdoor spaces.
- Designed by award-winning architects Hart Howerton and Interior Designer Hall of Fame inductee Meyer Davis.
- Private ocean view verandas and terraces are equipped with electricity and water service; these expansive private spaces are designed for outdoor entertaining.
- Chef's kitchens are integrated into the entertaining spaces with custom millwork cabinetry, Calacatta countertops and backsplashes, and a best-in-class imported European appliance suite.
- Bathrooms are appointed in a selection of natural stones including travertine and limestone. Most five-fixture primary baths offer windowed soaking tubs capturing views of the Ocean.
- Elevated 10-foot ceiling heights throughout living spaces.
- Secured parking and controlled access through private elevators.
- Owners meeting specified requirements can participate in Mandarin Oriental's rental program.



Private Residences Ocean House

Perched on the ocean cliffs, Ocean House offers the utmost in privacy. The exclusively residential offering features a curvaceous façade, framed by gracious private wrap-around terraces, erasing the boundaries between indoor and outdoor living.

- A porte cochere leads to the double-height attended lobby, finished in handsome oak millwork and luminous limestone flooring and surrounds.
- A boutique collection of 22 two, three, and four-bedroom residences.
- Ocean House Club, reserved for owners, includes a grand social lounge opening onto a dramatically landscaped infinity pool overlooking the ocean.
- Owners enjoy all the amenities and services of Mandarin Oriental.
- Architecture and interiors by Paris-based AW2, winner of the Leading Designer Award.
- The finishes reflect the caliber of a private home commission, pairing limestone flooring with oak millwork and stone, marble, and brass detailing.
- Exhibition kitchens fitted with a best-in-class integrated appliance package and hand-crafted millwork cabinetry with a fluted oak upper cabinet design.
- Primary baths are clad in richly luminous limestone, oversized soaking tubs are framed by the background of the ocean.
- Airy 9'6" ceiling heights throughout residences.

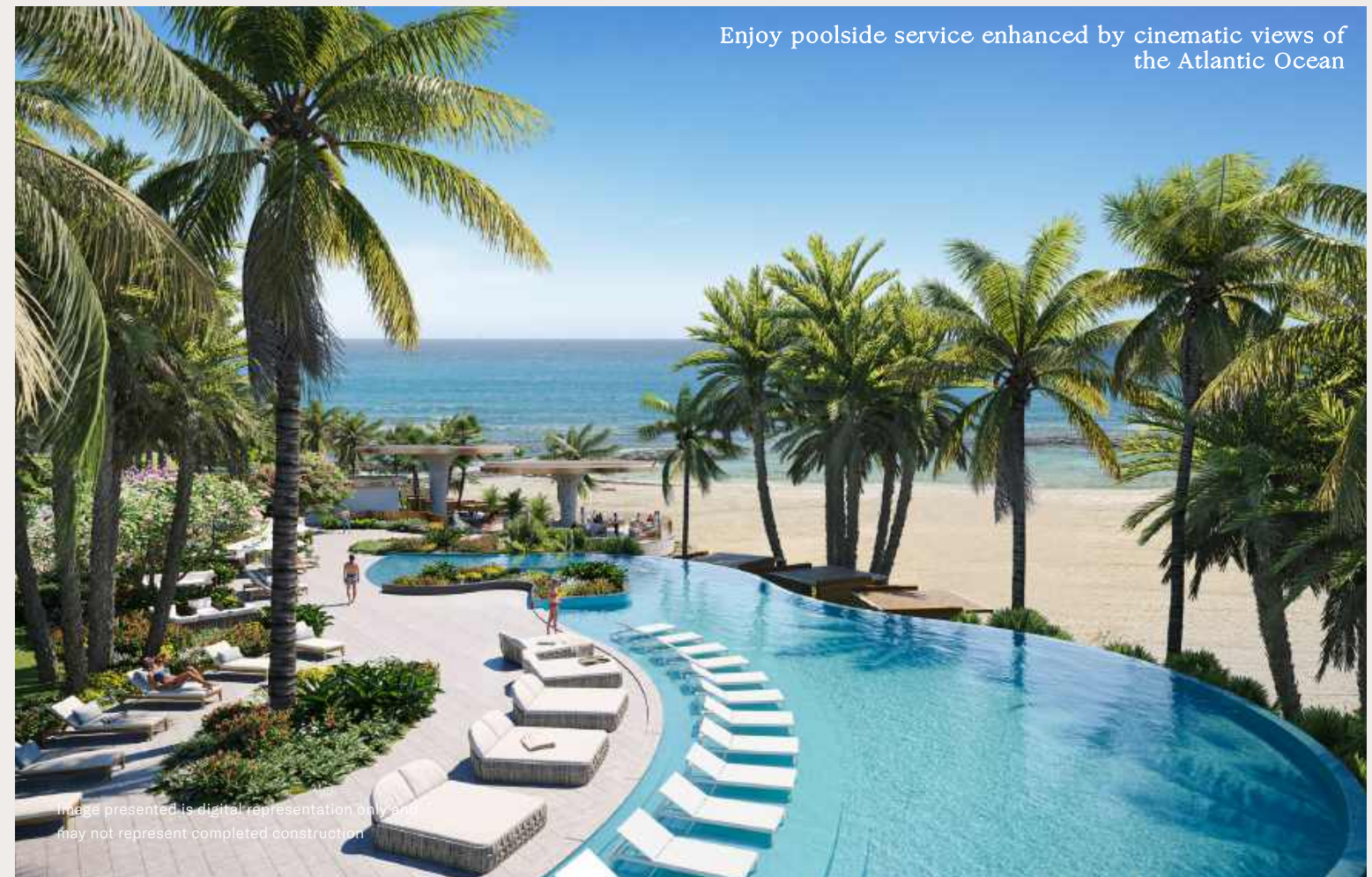

Frequently Asked Questions

What are the benefits of owning on Grand Cayman?

Grand Cayman enjoys the highest standard of living in the Caribbean. As a British Overseas Territory, the Cayman Islands have a stable UK-based government and a legal system based on English common law. The Cayman Islands use U.S. currency interchangeably with the Cayman dollar at a fixed exchange rate. Grand Cayman offers a strong economy, a temperate climate, and a vibrant lifestyle – including a reputation as “the Culinary Capital of the Caribbean” with more than 200 restaurants. Multiple direct daily flights arrive at The Owen Roberts International Airport (GCM) from Miami and Tampa (about a 90-minute flight), with regular direct flights from New York, Charlotte, Chicago, Atlanta, Dallas, Houston, Toronto, London (with a stop in Nassau) and other gateways. Airlines that service GCM include Air Canada, American Airlines, British Airways, Caribbean Airlines, Delta Airlines, JetBlue Airways, Southwest, United Airlines and WestJet, as well as Cayman Airways.

Where is Mandarin Oriental, Grand Cayman located?

St. James Point is about 20 minutes east of the international airport, on the southern-most coast of the island. Its location provides seclusion from tourist crowds, but easy access to conveniences. The South-facing oceanfront resort location also features open spaces and tropical vegetation not found at other luxury properties on Grand Cayman.

Where are the nearest medical facilities?

Grand Cayman has three fully equipped, modern hospitals. A state-of-the-art health center is less than 10 minutes from the resort.

How are the schools?

Grand Cayman has a wide variety of excellent public and private schools from preschool to university level, many situated in nearby George Town. Schools following the US system offer either the IB program or prepares students to take the Scholastic Aptitude Test (SAT) and attain a US High School Diploma; those following the UK system take GCSEs and A Levels.

How is the Grand Cayman economy?

The Cayman Islands’ well-regulated, tax neutral environment is highly regarded internationally. As the world’s leading domicile for offshore hedge funds and one of the largest captive insurance centers, it is the offshore jurisdiction of choice for both private and institutional investors. There are 125 banks in the Cayman Islands, most of which are subsidiaries of global banks. Grand Cayman imposes no income, capital gains, payroll or other direct taxation on corporations or individuals resident in the Cayman Islands.

Can Residences owners obtain Cayman Island residency?

Our owners can obtain a Certificate of Permanent Residence that provides a lifetime right to reside in the Cayman Islands by investing a minimum of US \$2.4 million in developed real estate. This option can offer a pathway to naturalization as a British Overseas Territories Citizen, which enables you to apply for full British Citizenry and obtain a British passport.

How does real estate ownership work in The Cayman Islands?

The Cayman government maintains the Cayman Islands Land Registry, in which every parcel of property is mapped and given a descriptive title number. Any encumbrances, such as mortgages, easements/rights-of-way and pending purchase contracts are recorded on the title register of the property. Since title is guaranteed by the Cayman government, there is no need for title searches, title companies or title insurance.

What is the land tenure?

The land tenure is defined as a ‘Strata’. A freehold property is subdivided into strata lots, each with its own strata title. This is the most common type of property tenure for residential condominiums. Strata owners are members of the strata corporation, which is responsible for the insurance, maintenance, and upkeep of the common areas of the property.

Is Cayman financing available for the purchase of my Residence?

Yes. The developer’s sales team will be pleased to recommend a selection of lenders and the loan officer will advise on their bank’s requirements.

How is closing on my Residence handled in Grand Cayman?

A typical conveyance takes no more than four weeks, with registration of the new owner at the Land and Survey Department occurring four to six weeks after that. While there are no property taxes in The Cayman Islands, there is a Stamp Duty of 7.5% of the sales price of the property that is paid after closing to register title.

When will the Residences be completed?

Completion of the Resort is scheduled for Q1 2028.

How has the resort’s construction taken hurricanes into account?

Renowned resort architects Hart Howerton have taken advantage of St. James Point’s elevation and have incorporated the best-in-class Miami- Dade weather sustainability standards which are some of the strictest building codes in the United States.

Is there a Homeowners’ Association for the Residences?

A number of Strata Corporations (Homeowners’ Associations) will be established to insure the property and maintain it for the benefit of the owners. The Strata budget is being prepared in collaboration with the Developer and Mandarin Oriental, and will encompass utilities, common area maintenance, replacement cost insurance and other shared expenses.

Am I allowed to rent my Residence?

Yes. Residences that meet Mandarin Oriental’s standards and furniture requirements can participate in the resort’s rental program. More information is available in separate documents.

Is the Resort pet friendly?

Yes! Specific limitations will be included in the Strata documents.
